

# BREATHING NEW LIFE INTO CRYPTO ASSETS

## Status Quo

Crypto market participants have limited and risky options to borrow or lend crypto assets to earn yield, raise liquidity or go short. They require using exchanges like Bitfinex, Poloniex etc. Asset borrowers and lenders are price takers and are exposed to uncertain counterparty risk of unregulated entities.

## Future

Oxygen is the first decentralized repo platform deployed on the Ethereum network. It is a peer-to-peer platform which enables crypto community to borrow and lend crypto assets in a safe and legally compliant way.

## Market Overview

- A repo is an agreement to sell securities and repurchase them on a specified future date ("maturity") at a pre-agreed price. Economically repo is as a loan secured against collateral.
- Repo is the oil that lubricates financial markets; more than \$12 trillion repos outstanding in US and Europe.
- Cryptoassets are a rapidly evolving asset class, with current market capitalisation \$500+ billion, 3200% higher than in January 2017. They are gaining mainstream acceptance.
